

The DMERT Group is a non-profit certifying body tasked with setting the benchmark for durable medical equipment and complex rehab repair training standards. By collaborating with the entire industry, the DMERT Group serves to establish standardized training guidelines. U.S. Rehab is partnering with the DMERT Group to offer a training program that has a number of benefits for employers, prospective students, and the industry as a whole.

The DMERT Certification is separated into three training levels:

**DMERT LEVEL 1**: Basic medical equipment from walkers and manual wheelchairs to hospital beds, scooters, and Group 2 consumer power chairs.

**DMERT LEVEL 2**: CRT manual wheelchairs, Group 3 power chairs, and basic seating adjustments and installation.

**DMERT LEVEL 3**: Technician trainer able to teach and train in community colleges or any other approved training venue.

To obtain each certification, technicians must pass an online theory exam and in-person competency exam.
